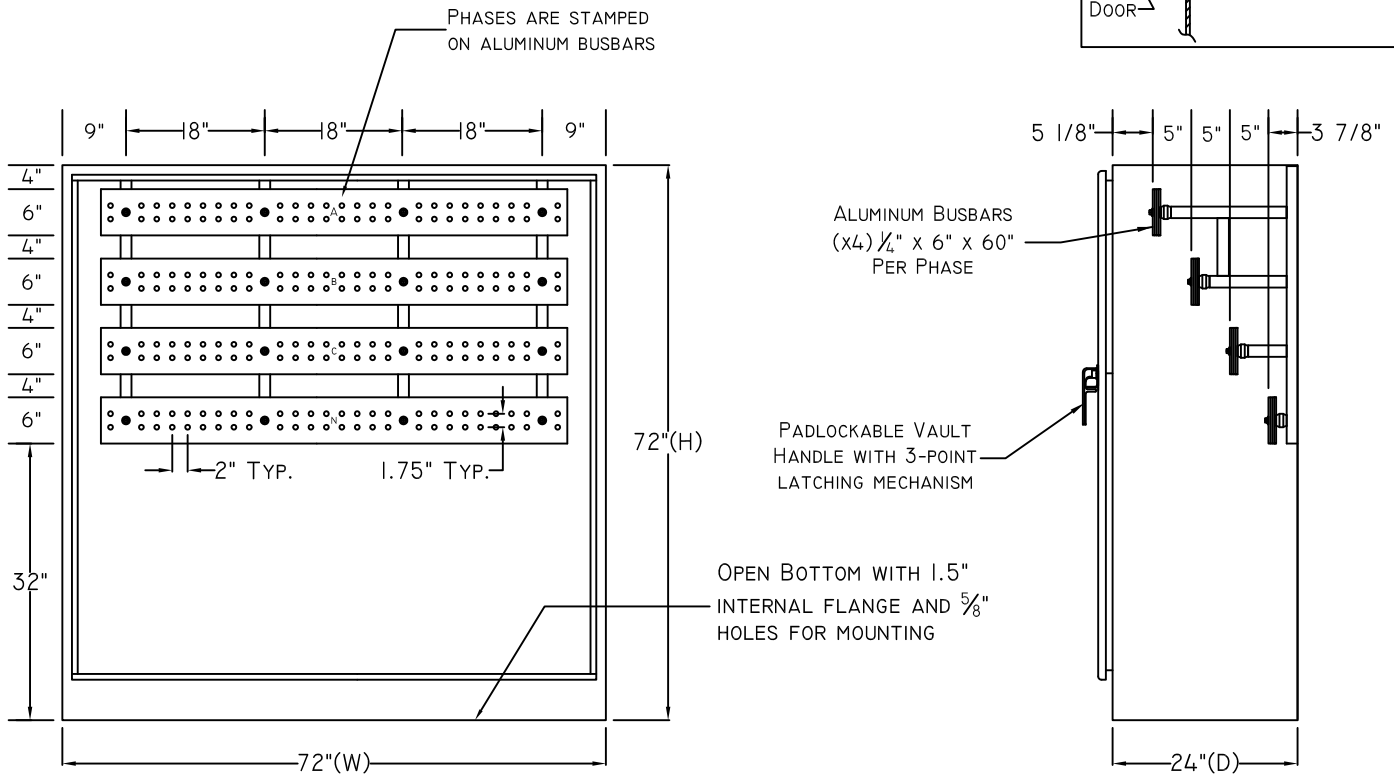
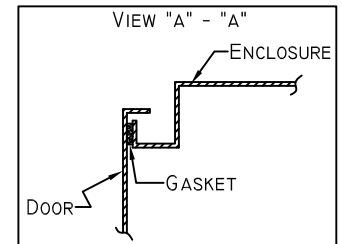

- ❑ DOUBLE DOORS PROVIDED WITH CONTINUOUS, STAINLESS STEEL PIANO HINGES. 3 POINT LATCHING MECHANISM SUPPLIED WITH PADLOCKABLE HANDLE. BOTTOM IS OPEN WITH A 1.5" INTERNAL FLANGE AND  $\frac{5}{8}$ " HOLES FOR MOUNTING.
- ❑ BUSBARS ARE FABRICATED FROM ALUMINUM ALLOY BAR STOCK,  $\frac{1}{4}$ " THICK, 6101-T61 IN ACCORDANCE WITH ASTM B317. BUSBARS ARE PUNCHED TO ACCOMMODATE STANDARD 2 HOLE HIGH-PRESS LUGS.

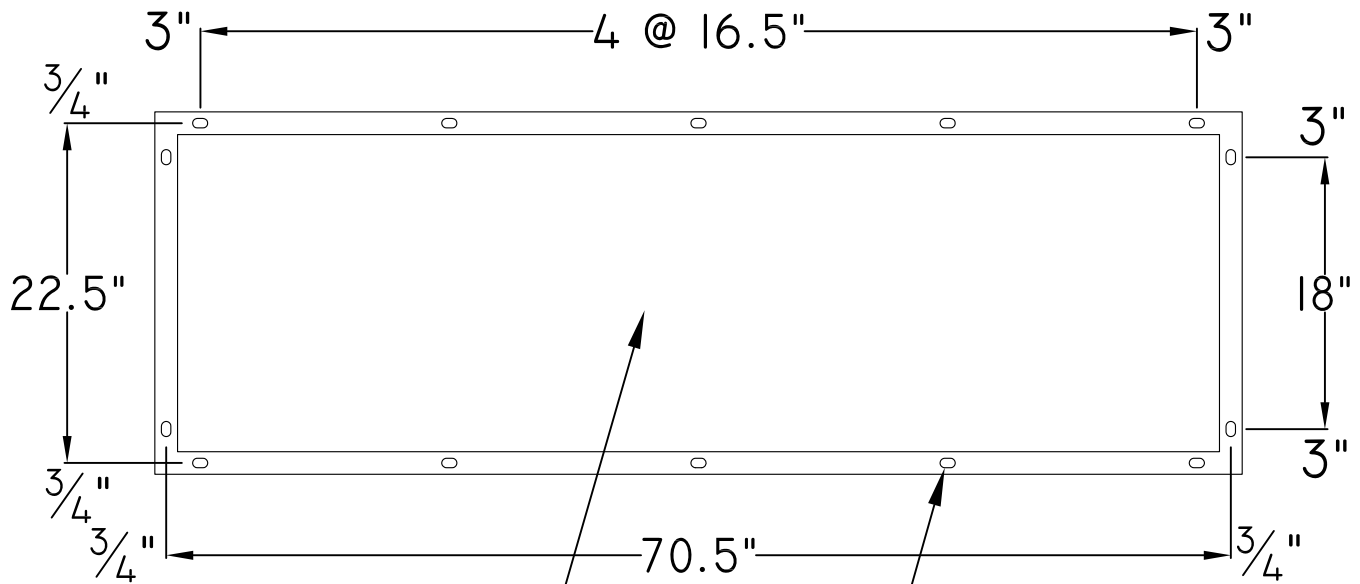
